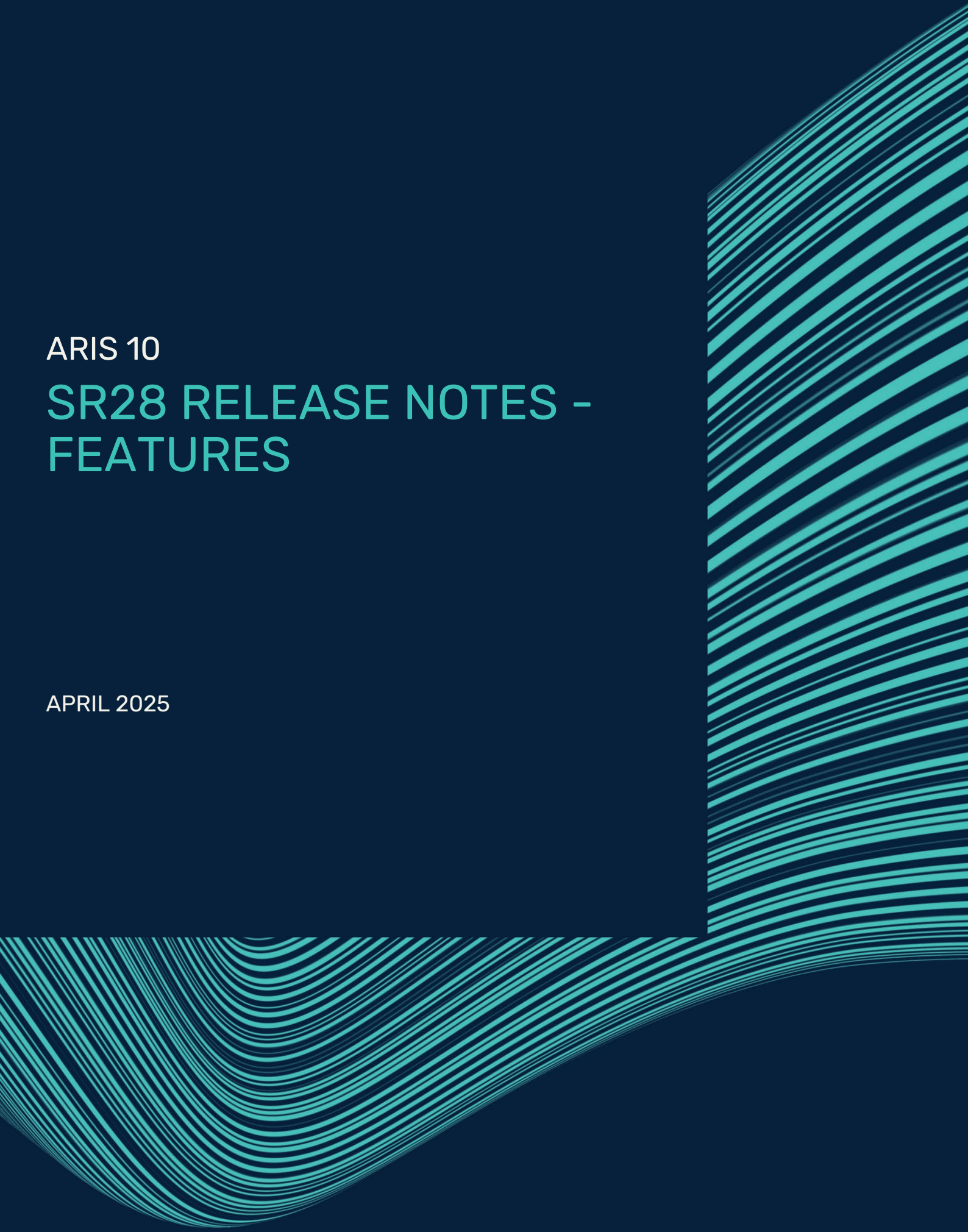

ARIS Enterprise - Admin	
Boost relevant contents by applying filters to home page	Give content consumers a head-start and provide a pre-filtered ARIS home page on login, which gives quick access to more relevant content, and personalized start pages.
Use WYSIWYG editor to configure the Catalog view	<p>Ready-to-use catalog views drive end user adoption and help finding published contents quickly. As portal administrator you are now able to adjust our standard catalog view via WYSIWYG editor. Also, you may add any new categories and adapt the views to fit the needs of your users.</p> <p>Based on customer idea PUB-I-4550</p>
Boost Portal Navigation: Shape your own navigation experience	Focus the end user's attention and guide their navigation behavior. Choose the portal items of choice, shape the one click navigation experience you want in order to drive end user adoption and configure to skip navigation to any allocation diagrams.
Privilege management for bulk editing	Administrators can configure user permissions for bulk editing on a per-database basis. By default, bulk editing is disabled for all users. Starting from SR28, this privilege must be explicitly granted.
Aligned setup and administration of ARIS workflows	ARIS Admins now benefit from a redesigned administration area for a more standardized selection and setup of standard approval workflows.

AI-enabled object reuse	The Companion reuses content from the repository when creating model drafts. When you provide text to the Companion, it matches the input text to objects in the repository and reuses similar objects.

XML content types	Administrators can adopt changes to the standard content type configuration faster. They no longer have to manually create their custom content types from scratch via the UI. To adopt improvements of the default configuration, admins can export the default and their custom configuration for a side-by-side comparison and alignment using external XML editors.
