1 General usage conditions

Customers must agree that anonymized data in the form of events are sent to the ARIS Cloud Enterprise Metering system (ACE Metering) to track the usage of the ARIS installation.

Performance degradation may occur depending on customer usage scenarios and patterns, for example:

- Very high numbers of viewers and modelers simultaneously viewing and working with workspace content in the same database in combination with large amounts of data in this database. It is strongly recommended to separate content to be displayed from content that is being modeled. You can either publish a specific version that differs from the workspace or provide the content to be displayed in a separate database. Please contact Software GmbH for best practices in this regard.
- High numbers of completed Process Governance (APG) workflow instances. Performance can be improved by frequent archiving (every 5.000 workflows).

Also, the general disclaimer from the product documentation applies:

ARIS products are intended and developed for use by natural persons. Automated processes, such as the generation of content and the import of objects/artifacts via interfaces, can lead to an outsized amount of data, and their execution may exceed processing capacities and physical limits. For example, processing capacities are exceeded if models and diagrams transcend the size of the modeling area, or an extremely high number of processing operations are started simultaneously. Physical limits may be exceeded if the memory available is not sufficient for the execution of operations or the storage of data.
